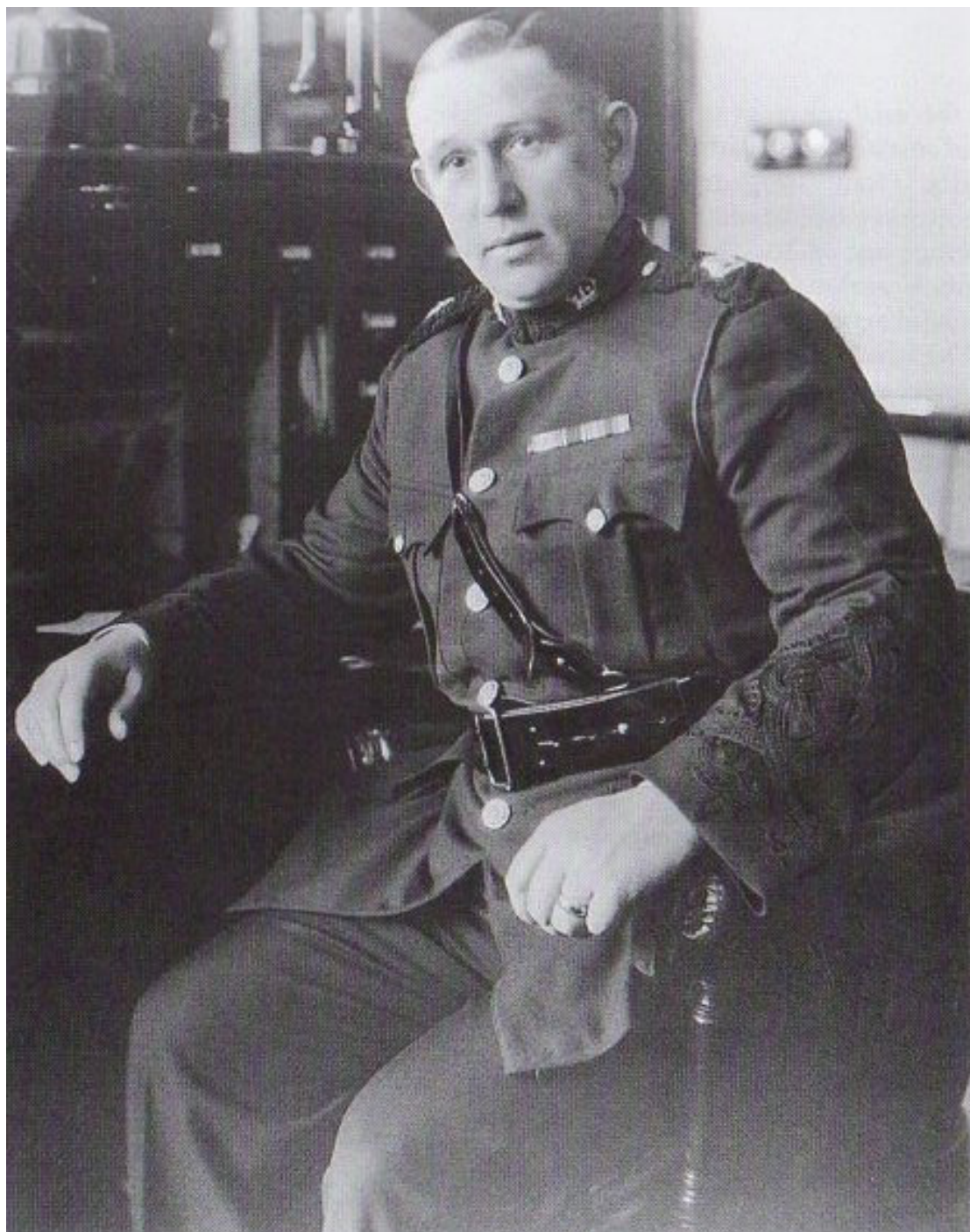


As your Chief Constable you can perhaps realise within a little how proud I am at your success in the Colman Cup Competition, for First Aid Teams.

"APPREHENSION OF SHOP-BREAKERS AT REDHILL"
27th February, 1936.

The Chief Constable refers to the above case which was heard at the SURREY ASSIZES on Wednesday 28th. February, 1936, before Mr. JUSTICE FINLAY

where Arthur JARVIS, Frederick George BISHOP and Albert Charles READ were charged with breaking and entering and stealing a quantity of Cigarettes valued at £22. from a Shop in Brook Road, Redhill.

The vigilance of SERGEANT H.A. ATKINS of Redhill Division is responsible for the detection of this Offence. It shows how necessary an officer has to be ALERT even at this time in the morning - it certainly was good Police Work and the COMMENDATION is deserving, and it gives the Chief Constable great pleasure to make these observations on this case.

P.C. 21 GODDARD of the MERTHEM SECTION is to be commended upon his prompt attention to duty and vigilance and observation in respect of the youth he apprehended at MERTHEM RAILWAY STATION. Circulation and information plays a big part in the detection of crime and the apprehension of the offenders, and the promptitude of officers in getting the information broadcast, following upon the apprehension of the man READ by Sergeant ATKINS has its own results in this case.

CO-OPERATION is the next point on which I wish to speak. This has been an ideal case throughout. It shows itself how we must communicate and get in touch in every way with Officers of other Forces. P.C. DODD of the Surrey County Constabulary is to be COMMENDED upon his action in making a search for the third man who he eventually apprehended at GODSTONE.

This case has now been brought to a satisfactory conclusion, and this has been due to the initiative of POLICE SERGEANT ATKINS in tackling the three men in REDHILL on the morning of the case.

is to be complimented on his turn out so rapidly to the call, his subsequent activities which lead to the arrest of one of the Prisoners outside the Borough, in somewhat difficult circumstances the Prisoner PEARSON was apprehended after having crossed the fields and boarded a Green Line Coach where he was found by this Officer - really creditable work. The Chief Constable had pleasure in endorsing the Divisional Inspector's remarks on this arrest.

Police Constable 21. John C. GODSMARK.

is also to be complimented for his vigilance and attention to duty displayed in his conscientious performance of attending lock-up property, it shows that this Officer was on the job when he found the two prisoner's on the premises, and his rapid action brought about the arrest of the second prisoner, referred to above, this officer having already arrested prisoner WHAPHAM.

The Chief Constable is very pleased with the work of these two officers on the night in question, which led to the following, that at-

SURETY SESSIONS, Wednesday 16th. Decr. 1936.

Prisoners pleaded "Guilty" to the offence under the Act quoted above, and each was bound over in the sum of £5. 0s. 0d. for 12 months, to be of good behaviour, and to come up for judgement if called upon.

They were also ordered to pay £2. 0s. 0d. towards the cost of damage and £4. to defray the cost of the prosecution.

Good work on the part of the Officers above mentioned.

P.C. GODSMARK acted promptly upon receiving the
report of the offence, and in a manner which was
absolutely necessary - even if the crime had not been
as serious as this one was. The officer had no
information as to the suspect and acted entirely on
his own initiative and detained "LIGHT" on suspicion.

The action taken by P.C. GODSMARK is worthy of
note, and his good work brought about a speedy
arrest of a man who had committed one of the most
serious offences known. P.C. Godsmark is deserving
of credit and this the Chief Constable records with
a COMMENDATION.
